

Dear member of the CDL,

This form explains the requirements for the participants for the Lustrum Trip of 2026 to Chile. Please read the form in its entirety, to avoid misunderstanding.

Costs: Maximum €1100
Period: 6th of July, 2026 ~ 26th of July, 2026
Max. no. of participants: 25

REGISTRATION IS OPEN UNTIL SEPTEMBER 14th, 2025

For transparency, our selection procedure is clarified below:

- 1) Your form will be categorized in one of four priority boxes. The boxes are as follows:

Box 1	<ul style="list-style-type: none">• Current LRC members;• Members of the CDL board
Box 2	<ul style="list-style-type: none">• 3rd-year BSc students who - at August 31st 2025 - have the nominal amount of ECTS (120 ECTS);• 1st-year MSc students who completed their BSc in the time set by their institute (excluding a full-time CDL or S.V. LIFE board year);• 2nd-year MSc students who plan to finish their MSc in the time set by their institute with an achievable planning.• Former MexCie, ForExCie and LRC members that have not previously participated on a foreign excursion (excluding the BRC) they have not organized themselves.
Box 3	<ul style="list-style-type: none">• 3rd-year BSc students and up who expect to have obtained more than 120 ECTS by August 31st 2026;• MSc students who do not fit in the first two boxes.
Box 4	<ul style="list-style-type: none">• Buitengewone members

N.B.: All boxes are based on the academic year 2025-2026

- 2) Members are selected from the boxes according to motivation. The draft continues in one box until that box is empty, or until no more free spots are available. If you belong to more than one box, the highest box applies.
- 3) Selected members are informed via the e-mail address they provided. Members that are not selected are given the option to keep their form in the draft, or to withdraw from the draft. Those that keep their form in the draft may still receive a place, if spots become available.

By submitting your registration, you automatically agree to the following terms:

- I. If you are selected, you deposit part of the participation contribution, which amounts to **€600**, to NL97INGB0000613060 in the name of Chemisch Dispuut Leiden **before September 28th, 2025**. If the required sum is not received by September 28th, 2025, your place on the trip is passed on to another person selected from the waiting list. The waiting list uses the same box system. If you are selected from the waiting list, you deposit the required sum to the above-mentioned bank account **before October 5th, 2025**. If the required sum is not received by October 5th, 2025, your place on the trip is again passed on.
 - a. If you were selected and have made the first deposit, you deposit the second deposit of **€200 before November 30th, 2025**. If the sum is not received and warnings by the committee are ignored, your place on the trip will be passed on to another person selected from the waiting list
 - b. If you were selected and have made the first and second deposit, you deposit the third deposit of **€200 before January 31st, 2026**. If the sum is not received and warnings by the committee are ignored, your place on the trip will be passed on to another person selected from the waiting list.
 - c. If you were selected and have made the first, second and third deposit, you deposit the final deposit of **€100 before March 31st, 2026**. If the sum is not received and warnings by the committee are ignored, your place on the trip will be passed on to another person selected from the waiting list.
- II. All participants are required to participate on a **40-hour case study/workweek**. The raised funds will be used to finance part of the trip.
 - a. In case a non-chemical related workweek is organised, a participant is free to use their own job or opt out by paying **an additional fee of €600**.
- III. If you are selected, please provide your personal information to the Lustrum Trip Committee via e-mail **before September 28th, 2025** (excluding for members selected from the waiting list). This information should include the following:
 - a. your full name;
 - b. your date of birth;
 - c. your current address;
 - d. a legible, digital copy of the passport you will be travelling with (front- & backside)*;
 - e. the document number of the passport you will be travelling with;
 - f. your health insurance information;
 - g. your telephone number.
 - h. Your ICE contact (emergency contact name and number)

*The travel document you send a copy of must be valid for at least 6 months during the trip.

The CDL and the LRC promise to handle personal information and documents in a secure manner, and to use it only for the necessary purposes.

IV. If you are selected, you must:

- a. attend all company, university or embassy visits;
- b. ensure you are presentable and professional on company, university and embassy visits;
- c. behave in an appropriate and professional manner during the excursion;
- d. respect and abide by reasonable decisions of the LRC and the board;
- e. keep track of time to prevent delay;
- f. avoid vandalism, violence and other situations and actions that might pose risks to you, other participants of the trip and/or non-related persons;
- g. hold to the applicable legislation of Chile and the Netherlands.

If you violate any of the above-mentioned rules, the committee may decide to exclude you from further participation on the trip and send you home at your own expense.

- V. To travel to Chile no mandatory vaccination is required. However, Hepatitis A and DTP (diphtheria, tetanus and polio) are strongly recommended (see ggdreisvaccinaties.nl). Chemisch Dispuut Leiden is **not responsible** for you to get **vaccinated**. You can do this at your own initiative and costs.
